In particular, I would like to express my high respect and appreciation to China and the Chinese people, who have shown their great power with great responsibilities.

Currently, the global pandemic is still severe. The task of defeating the pandemic is very arduous. This requires the continued joint efforts of all countries and close cooperation with the international community. I hope that we will overcome the pandemic as soon as possible, and will restore normal production and living order.

Mr. President, leaders, and representatives.

Health is the universal desire and pursuit of all mankind. It is the cornerstone of the full development and happy life. It is also an important symbol of the prosperity of the society, and the development and progress of human civilization. Each of us, society and country need not only a good health, but also high-level and long- lasting health, that is, achieving healthy and sustainable development. Promoting health means achieving good health and well-being. It is one of the 17 UN Sustainable Development Goals. It is also an important part of building a community with the future.

At the same time, the wave of the global health industry is coming. It has already been a new industry with great development potential and prospects. It becomes a new engine leading the global economic development and social civilization progress in the 21st century, with potential to be the world's largest industry. It is a huge industrial cluster with broad development prospects, which involves many fields of production and life closely related to human health, such as medical and medicine, nutrition and healthcare, health services, health technology, healthy environment, and healthy human settlements. Since the well-

known economist Paul Pilzer pointed out in his book "The Fifth Wave of Wealth" that the health industry will become the prediction of the global "Fifth Wave of Wealth" after the information industry, the upsurge of developing the health industry is rapidly rising around the world. In fact, in recent years, the health industry has become a strategic choice for many countries in the world, especially the development countries in Europe and the United States, and the emerging market countries.

Its objectives are to actively seek to establish a wide range of global health partnership with worldwide governments, non-governmental organizations, social communities, business enterprises, especially in the field of health, investment, science and technology, and academia. Additionally, UNHIF co-develops health industry and health undertakings with partners through the construction of "global health network" and global health cooperation system, promotes the establishment of a sustainable global health system, and create a global health wealth feast that shares a multilateral win-win situation.

Mr. President, leaders, and representatives.

The sustainable development of the global health industry requires the full cooperation of all countries and all walks of life, and extensive cooperative actions. The United Nations Health Industry Foundation will, through extensive collaboration, step by step launch a series of large-scale health industry cooperation plans that are open to the world to fulfilL its purpose, idea, responsibilities and mission.

First is health conference, THE UNHIF Global Health Conference, a series of international and regional health themed forums, summits, conferences, seminars, special meetings, have been initiated and organized to provide support for governments, organizations, business, investment, science and technology, academia, which have

established platforms and mechanisms for extensive exchanges, dialogue, and cooperation to discuss global health governance and health industry development.

Second is the UNHIF cooperation program. It is formulated for various countries and global health companies, including manufacturers, investors, suppliers, and service providers, to develop a group of excellent global partners, strategic partners and regional partners. Through the platform of UNHIF, a multi-party win-win, sustainable development global health industry cooperation framework and mechanism are built, and unlimited business opportunities are shared.

Third is UNHIF global partners. It is a program that select top partners from all over the world, invite leading companies and leaders in the global health sector, or those who plan to enter the health sector, to join the partnership to form the most complementary and close global top health investment institution in the health industry chain. We are committed to build the most powerful and influential health investment platform in the world, which will be the most valuable investment in the big health industry chain.

Fourth is health technology and innovation strategic plan. We will establish a number of important health technology innovation platforms through cooperation. These platforms are open the world. On the one hand, it let science and technology deeply integrate with health, which will promote the transformation of achievements in health technology field. These achievements will also be widely used in the fields of production and life. On the other hand, we will focus on the development of health technology industry, and realize the "the industrialization of health technology, innovating the health industry". Driven by these two wheels, science and technology will maximally benefit mankind and protect human life and health.

Fifth, incubation of health industry. We will establish a health industry incubation platform, which is open and shared to the world, through cooperation. A number of excellent health projects, health products and health enterprises will be cultivated and incubated through professional services. The focus is on incubating a group of outstanding listed companies and unicorn companies in health industry, helping them grow into the leaders in the global or regional health field.

Sixth, health investment development plan. Together with our partners, we will invest in multiple areas in the global health industry chain. As the same time, a number of health demonstration zones, demonstration bases, and demonstration projects, which are benchmarked against the United Nations Sustainable Development Goals, will be created globally through cooperation. In addition, we will build a that integrates comprehensive demonstrations of healthcare, health exhibitions, and health technology. These will be important carries that will pragmatically enhance human health and well-being.

Seventh, digital health strategy. Advocating digital health has become an important agenda for global health multilateral governance and health industry development. Cloud computing, big data, artificial intelligence, and other digital technologies will be utilized. On the one hand, we will establish a global shared health big data center, health brain and other important digital health infrastructure and smart application platforms. On the other hand, we will lead countries to deploy and implement digital health plans. The "two-wheel driven" strategy will lead the global development of digital health economy. Meanwhile, it will empower and promote the better development of the real health economy. I believe that through the digital health strategy, it will greatly reduce the inequality between the developed countries and poor countries, the poor and the rich, in the fields of healthcare and public health. It will also establish new order, help promote the agenda for United Nation Health Sustainable Development, and fulfill the vision of the national health.

Eighth, global health cooperation high-level group. It is initiated and established mainly to promote various related suggestions and strengthen cooperation among governments, organizations, industries and other relevant stakeholders in the health field. Members will be composed of outstanding leaders from different countries and industries. Its responsibilities are to advocate, guide and promote the development of the global health industry, the application of health technology, and the improvement of health governance. In this way, it will

better implement the United Nations sustainable development goals and the concept of a community with a shared future for all mankind.
